The ordinary resolution in respect of the above proposal will be tabled at the Annual General Meeting ("AGM") of CapitaLand Malaysia Trust ("CLMT") which will be held on Wednesday, 8 April 2026 at 10.00 a.m. at Nusantara Ballroom, Level 2, Sheraton Imperial Kuala Lumpur Hotel, Jalan Sultan Ismail, 50250 Kuala Lumpur, Malaysia.

The Notice of the AGM together with the Form of Proxy are enclosed in the Annual Report 2025 which is available at the website of CLMT at www.clmt.com.my. The Form of Proxy must be lodged with the Poll Administrator's office, Boardroom Share Registrars Sdn Bhd at 11th Floor, Menara Symphony, No. 5, Jalan Prof. Khoo Kay Kim, Seksyen 13, 46200 Petaling Jaya, Selangor Darul Ehsan, Malaysia, or at its website at <https://investor.boardroomlimited.com> ("eProxy Lodgement"), not less than 48 hours before the time appointed for holding the meeting or any adjournment thereof; in default of this provision, the Proxy Form shall not be treated as valid. The lodging of the Form of Proxy will not preclude you from attending and voting in person at the AGM should you subsequently wish to do so.

PROPOSED RENEWAL OF UNIT BUY-BACK MANDATE

1. INTRODUCTION

At the last AGM of CLMT held on 4 April 2025, the Unitholders, had among others, given a mandate for CLMT to re-purchase up to ten percent (10%) of the total number of issued Units at the time of purchase. The authority obtained by our Board for the re-purchase of Units will lapse at the conclusion of the forthcoming AGM of CLMT, unless a renewal of mandate for the unit buy-back authority is obtained from the Unitholders at the forthcoming AGM.

In connection with the above, on 28 January 2026, the Manager announced its intention to seek your approval for the ordinary resolution pertaining to the Proposed Renewal of Unit Buy-Back Mandate to be tabled at the forthcoming AGM.

The purpose of this Statement is to provide you with the details of the Proposed Renewal of Unit Buy-Back Mandate and to seek your approval for the ordinary resolution pertaining to the Proposed Renewal of Unit Buy-Back Mandate to be tabled at the forthcoming AGM. The Notice convening the AGM of CLMT and the Form of Proxy are enclosed in the Annual Report 2025.

2. DETAILS OF THE PROPOSED RENEWAL OF UNIT BUY-BACK MANDATE

At the AGM held on 4 April 2025, the Board of the Manager obtained Unitholders' authorisation for CLMT to re-purchase up to ten percent (10%) of its prevailing total number of issued Units. As at the LPD, no Units were repurchased. Under the existing authority, the Manager had not carried out any unit buyback during the period from April 2025 until 10 March 2026, being the date of this Statement and hence, there were no cancellations of repurchased Units from April 2025 up to the date of this Statement.

The Proposed Renewal of Unit Buy-Back Mandate, if approved by you, will allow the Manager to re-purchase Units of up to ten percent (10%) of the total number of issued Units. The re-purchase of Units is subject to compliance with the Listing Requirements and any prevailing rules and regulations issued by the relevant authorities at the time of the re-purchase.

The Manager may only re-purchase Units on Bursa Securities at a price not more than fifteen percent (15%) above the weighted average market price of the Units for the past five (5) market days immediately preceding the date of the re-purchase.

In accordance with Paragraph 12.28(4) of the Listing Requirements, the Units re-purchased pursuant to the Proposed Unit Buy-Back must be cancelled immediately.

The Proposed Renewal of Unit Buy-Back Mandate shall be effective upon the passing of the ordinary resolution at the forthcoming AGM and may continue to be in force until:-

- (a) the conclusion of the next AGM of CLMT, at which time the authority shall lapse, unless by an ordinary resolution passed at that meeting, the authority is renewed;
- (b) the expiration of the period within which the next AGM of CLMT is required by law to be held; or
- (c) the authority is revoked or varied by an ordinary resolution passed by the unitholders of CLMT in a general meeting,

whichever occurs first.

The Proposed Renewal of Unit Buy-Back Mandate does not impose an obligation on the Manager to re-purchase Units but rather, it allows the Board to exercise the power of the Manager to re-purchase Units at any time within the abovementioned period.

Where the Manager has repurchased the Units, the Board shall cancel the Units so repurchased immediately.

The Notice of the AGM together with the Form of Proxy are enclosed in the Annual Report 2025.

3. RATIONALE

The Proposed Renewal of Unit Buy-Back Mandate will provide the Manager with the opportunity to re-purchase Units in requisite situations such as for purposes of stabilising the supply and demand of Units traded on the Main Market of Bursa Securities, thereby allowing the price of Units to better reflect the fundamental value of the Units.

4. POTENTIAL ADVANTAGES AND DISADVANTAGES

Units re-purchased by the Manager will be cancelled immediately. Accordingly, the implementation of the Proposed Renewal of Unit Buy-Back Mandate may improve the DPU of CLMT and the return on equity as a result of a lower number of Units being taken into account for these computations.

However, the Proposed Renewal of Unit Buy-Back Mandate, if implemented, would reduce the financial resources available to CLMT and may consequently result in CLMT having to forego other feasible investment opportunities that may emerge in the future, or, at the least, deprive CLMT of any income that may be derived from the deposit of funds in interest bearing instruments. The Proposed Renewal of Unit Buy-Back Mandate would also reduce the amount of financial resources available for repayment of CLMT Group's borrowings, working capital or distribution in the form of income distribution to the Unitholders.

Nevertheless, the Board will be mindful of the interest of the CLMT Group and the Unitholders in implementing the Proposed Renewal of Unit Buy-Back Mandate and will ensure that any re-purchase of Units is made in good faith and in the best interest of the CLMT and the Unitholders.

5. SOURCE OF FUNDS

The re-purchase of Units will be funded from internally generated funds and/or external borrowings; and the maximum amount of funds allocated shall not exceed the retained profits of CLMT. Based on CLMT's latest audited financial statements for the financial year ended 31 December 2025, CLMT has RM298.0 million in its retained profits.

The proportion of internally generated funds and external borrowings (if obtained) to be allocated for the re-purchase of the Units will only be determined later and will depend on the availability of internally generated funds, CLMT Group's total borrowings, price and actual number of Units to be re-purchased and other relevant cost factors.

In the event that CLMT partly finances the re-purchase of its Units by borrowings, the Board shall ensure that the amount of borrowings is backed by an equivalent amount of retained profits and that the repayment of the related borrowings will not have a material effect on the cash flow of CLMT.

6. EFFECTS OF THE PROPOSED UNIT BUY-BACK

Assuming the Proposed Unit Buy-Back is carried out in full, effects of the Proposed Unit Buy-Back on the total number of issued Units, distributable income, DPU, NAV per Unit, gearing, working capital and earnings per Unit are set out below:-

6.1 Number of issued Units

Assuming the Manager re-purchases 333,127,548 Units representing ten percent (10%) of the total number of issued Units as at the LPD and all the Units re-purchased are cancelled, the effect on the total number of issued Units is as follows:-

6.2 Distributable income and DPU

The effects of the Proposed Unit Buy-Back on the distributable income of CLMT are dependent on the purchase price of Units, the number of Units re-purchased and the effective funding cost of the re-purchases. The reduced number of Units applicable in computing the DPU subsequent to the re-purchase of the Units will generally have a positive impact, all else being equal, on the DPU of CLMT.

6.3 NAV per Unit and gearing

The effects of the Proposed Unit Buy-Back on the NAV per Unit will depend on the purchase price of Units and number of Units re-purchased. The Proposed Unit Buy-Back will reduce the NAV per Unit if the purchase price exceeds the NAV per Unit at the time of the re-purchase. Conversely, it will increase the NAV per Unit if the purchase price is less than the NAV per Unit at the time of the purchase.

The effect of the Proposed Unit Buy-Back on the gearing of CLMT Group will depend on the quantum of borrowings used, if any, to fund the re-purchase of Units. The utilisation of any borrowings to fund the Proposed Unit Buy-Back will serve to increase the gearing of CLMT Group.

6.4 Working Capital

The Proposed Unit Buy-Back is likely to have the effect of reducing the working capital of CLMT Group, the quantum of which depends on the purchase price of Units, the number of Units re-purchased and any associated costs incurred in making the re-purchase.

6.5 Earnings per Unit

The effects of the Proposed Unit Buy-Back on the earnings per Unit of CLMT Group will depend on the purchase price of Units and number of Units purchased as well as any loss in interest income to CLMT Group and increase in finance cost from utilisation of borrowings to fund the Proposed Unit Buy-Back. The effective reduction in the number of Units applied in the computation of the earnings per Unit pursuant to the Proposed Unit Buy-Back may generally, all else being equal, have a positive impact on the earnings per Unit of CLMT Group.

7. DIRECTORS' AND SUBSTANTIAL UNITHOLDERS' UNITHOLDINGS

Assuming that the Proposed Unit Buy-Back is implemented in full and the Units purchased are from the unitholders of CLMT other than the Directors and/or Substantial Unitholders, the effect of the Proposed Unit Buy-Back on the unitholdings of the Directors and Substantial Unitholders respectively as at the LPD are illustrated below:-

8. PUBLIC UNITHOLDING SPREAD

The Proposed Unit Buy-Back will be carried out in accordance with the prevailing laws at the time of the re-purchase including compliance with the 25% public shareholding spread as required under paragraph 8.02(1) of the Listing Requirements.

As at the LPD, the public unitholding spread of CLMT was approximately 47.01%. In this regard, the Board will be mindful of the public shareholding spread requirement before making any re-purchases of Units pursuant to Proposed Unit Buy-Back.

9. IMPLICATIONS RELATING TO THE RULES ON TAKE-OVERS

The Rules on Take-Overs require a person, together with persons acting in concert with him, holding more than 33% but less than 50% of the total number of issued units in a listed Malaysian REIT and who as a result of a purchase by the REIT of its own units, increase his holding in any period of 6 months by more than 2% of the voting units in the REIT, to undertake a mandatory offer on the balance of the units not already owned. However, an exemption from a mandatory offer obligation may be granted by SC under the Rules on Take-Overs, subject to the affected parties complying with certain conditions.

As at the LPD, CMMT Investment Limited, which is a Substantial Unitholder, together with persons acting in concert, holds more than 33% but less than 50% of the total number of voting Units in CLMT. If the Proposed Unit Buy-Back results in the percentage of voting Units held by CMMT Investment Limited and persons acting in concert with it to increase by more than 2% within a period of 6 months, CMMT Investment Limited and persons acting in concert with it would be obliged to undertake a mandatory offer for the remaining Units not already owned by it.

The Manager does not intend to undertake the Proposed Unit Buy-Back such that it will trigger any obligation to undertake a mandatory offer pursuant to the Rules on Take-Overs for its Substantial Unitholders. However, in the event that an obligation to undertake a mandatory offer in relation to any party is expected to be triggered as a result of the implementation of the Proposed Unit Buy-Back, the affected Unitholder may apply to the SC for an exemption from undertaking a mandatory offer pursuant to the Rules on Take-Overs.

Accordingly, they recommend that you vote in favour of the ordinary resolution pertaining to the Proposed Renewal of Unit Buy-back Mandate to be tabled at the forthcoming AGM.

PROPOSED RENEWAL OF UNIT BUY-BACK AUTHORITY TO REPURCHASE UP TO TEN PERCENT (10%) OF THE TOTAL NUMBER OF UNITS ISSUED (“PROPOSED RENEWAL OF UNIT BUY-BACK MANDATE”)

“**THAT** subject to the Main Market Listing Requirements (“**Listing Requirements**”) of Bursa Malaysia Securities Berhad (“**Bursa Securities**”), provisions of the trust deed dated 7 June 2010 (as amended and restated on 13 July 2021), and any prevailing laws, guidelines, rules and regulations issued by the relevant authorities, the Board of the Manager (“**Board**”) shall be authorised to repurchase the units in CapitaLand Malaysia Trust (“**CLMT**”) (“**Units**”) for and on behalf of CLMT through Bursa Securities, subject to the following:

- (a) the aggregate number of Units in CLMT which may be repurchased shall not exceed ten percent (10%) of the total number of Units issued at the time of purchase and the compliance with the public unitholding spread requirements as stipulated under the Listing Requirements;
- (b) the maximum funds to be allocated by CLMT for the purpose of repurchasing the Units shall not exceed the aggregate of the retained profits of CLMT based on the latest audited financial statements of CLMT available at the time of purchase;
- (c) the authority conferred by this resolution shall be effective and continue to be in force from the date the unitholders of CLMT (“**Unitholders**”) pass this resolution, until:
 - (i) the conclusion of the next annual general meeting (“**AGM**”) of the Unitholders at which time it shall lapse, unless by a resolution passed at the meeting, the authority is renewed; or
 - (ii) the expiration of the period within which the next AGM of the Unitholders is required by law to be held; or
 - (iii) the authority is revoked or varied by the Unitholders in a Unitholders’ general meeting,

whichever occurs first;

THAT where the Manager has repurchased the Units, the Board shall cancel the Units so repurchased immediately.

AND THAT authority be and is hereby given to the Board, for and on behalf of CLMT, to sign and execute all documents, and do all acts and things as may be required for or in connection with and to give effect to, and to implement the Proposed Renewal of Unit Buy-Back Mandate with full power to do all such acts as they may consider necessary or expedient in the best interest of CLMT and its Unitholders so as to give full effect to the same with further power to assent to any condition, modification, variation and/or amendment as may be required or imposed by the relevant authorities.”
